Purpose

St Nicholas is committed to the delivery of services consistent with the principles and standards detailed in the resource Integrity in the Service of the Church and ensuring that these services support the health and well-being of children in our care.

Children in the care of St Nicholas and their families need to feel confident in the care provided and aware of the internal processes of St Nicholas for the care of their children.

Policy

All families and their children will be provided with an orientation prior to commencement to ensure awareness of internal processes that support the health and well-being of their children.

Definitions

For the purpose of this policy:

- "Orientation" means a structured program presenting core information relating to the health and well-being of the child and internal processes and systems administered by St Nicholas staff that include:
 - o Immunisation
 - o Infection control
 - o Delivery and collection of children
 - o Contact details
 - o Child illnesses
 - o Excursions
 - o Nutrition and dietary requirements
 - o Clothing and sun protection
 - o Introduction to room/service Educators and explanation of daily routine
 - o ELYF/MTOP and educational program

Scope

The policy relates to all staff and families with children in the care of St Nicholas.
